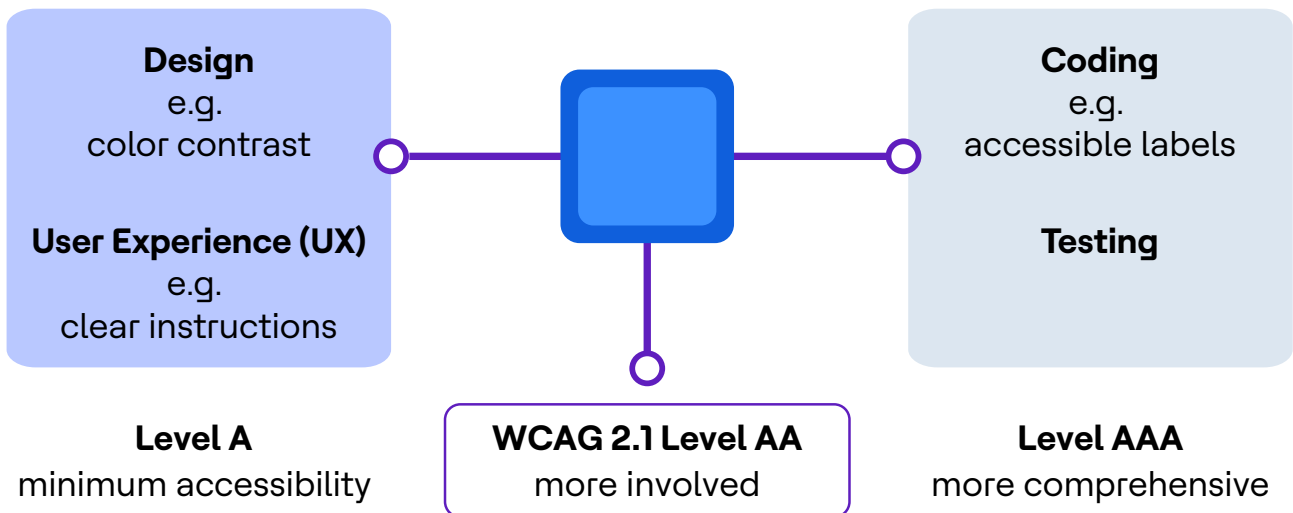

To accomplish Level AA compliance, we ensure that all factors during the design, developing and testing process pass the web content accessibility guidelines.

Depending on the selected font family, we inspect and recommend the minimum font size as per the color contrast. Letter spacing and line spacing is suggested to keep at least 25 percent of the font size and set paragraph spacing at least 1.5 times of the font size.</p>

### Cognition

We suggest meaningful, non-specialized field labels and instructions to minimize confusion. All interactive elements are accompanied by easy-to-understand instructions, which describe the purpose of selection texts with no spelling mistakes error messages to avoid user confusion or abandonment of appropriate field auto-completion.



### Layouts

We design simple and consistent layouts for quick and easy access of functionalities. Information findability and accessibility are accomplished by using a simple, straightforward and consistent layout. Proper information architecture and easy-to-understand navigation are achieved by using the keyboard with proper content and visual focus, skipping duplicate content.

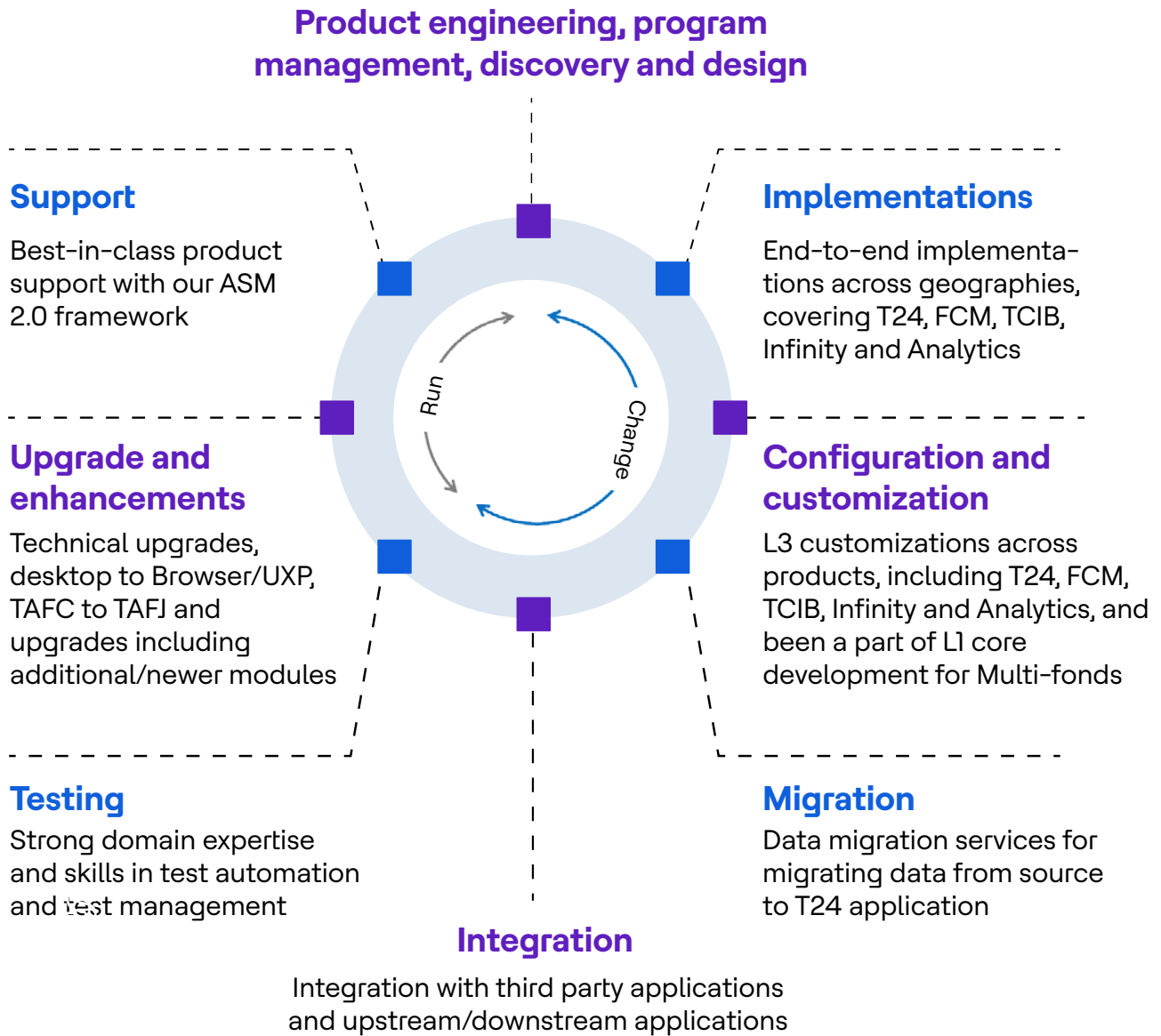
