Accordingly his proportionate shareholding in HCL Technologies Limited ('Company') comes to 0.10%. The balance 43.05% share in HCL Corporation Private Limited are held by other family members (Mrs. Kiran Nadar and Mrs. Roshni Nadar Malhotra). Accordingly, the aggregate shareholding of Mr. Shiv Nadar along with his family members in the company is 0.17%.
- 3 HCL Healthcare Private Limited is owned by Slocum Healthcare Private Limited which is 100 % Owned by Vamasundari Investments (Delhi )Private Limited. Therefore, Ultimate Parent Company of HCL Healthcare Private Limited is Vamasundari Investments (Delhi) Private Limited. So, Vamasundari indirectly holds 92.7 % share in HCL Avitas Pvt Ltd. Mr. Shiv Nadar (SBO ID-SB00038683) aggregate shareholding along with his family members in HCL Avitas Private Limited is 0.30%.

Since, it is a discretionary trust, interest of none of the beneficiaries has materialized or crystallized as on the date of this disclosure and, as a consequence, cannot be determined.
