### View a list of network activities and drill down for further details.

The **Find Network Activity** app provides a filtered list of network activities. Order date conflicts are shown on the list, and various update actions are provided. Drilling into the network activity detail page provides a list of related orders and the ability to maintain relationships between network activities.

### View a list of material requirements and review the coverage status.

The **Find Order Component** app provides a filtered list of order components (material requirements) for an event (revision) or a specific network activity. The material coverage within a 42-day-time window is displayed in the list. Drilling down into the component details displays further details of the material requirement.
