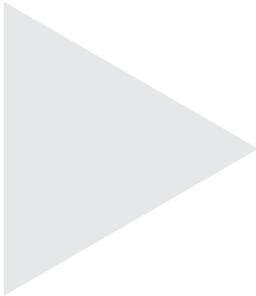
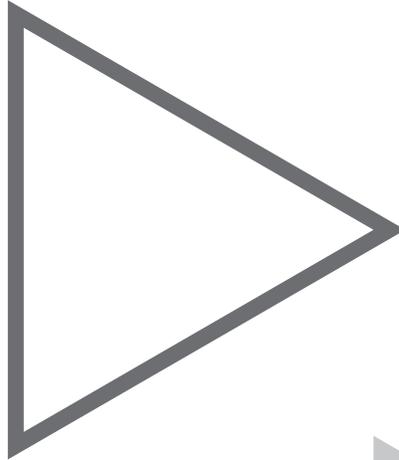

Our comprehensive Assessment Framework has been designed to determine the right answers for your organization – based on your needs, your budget, and your current landscape.

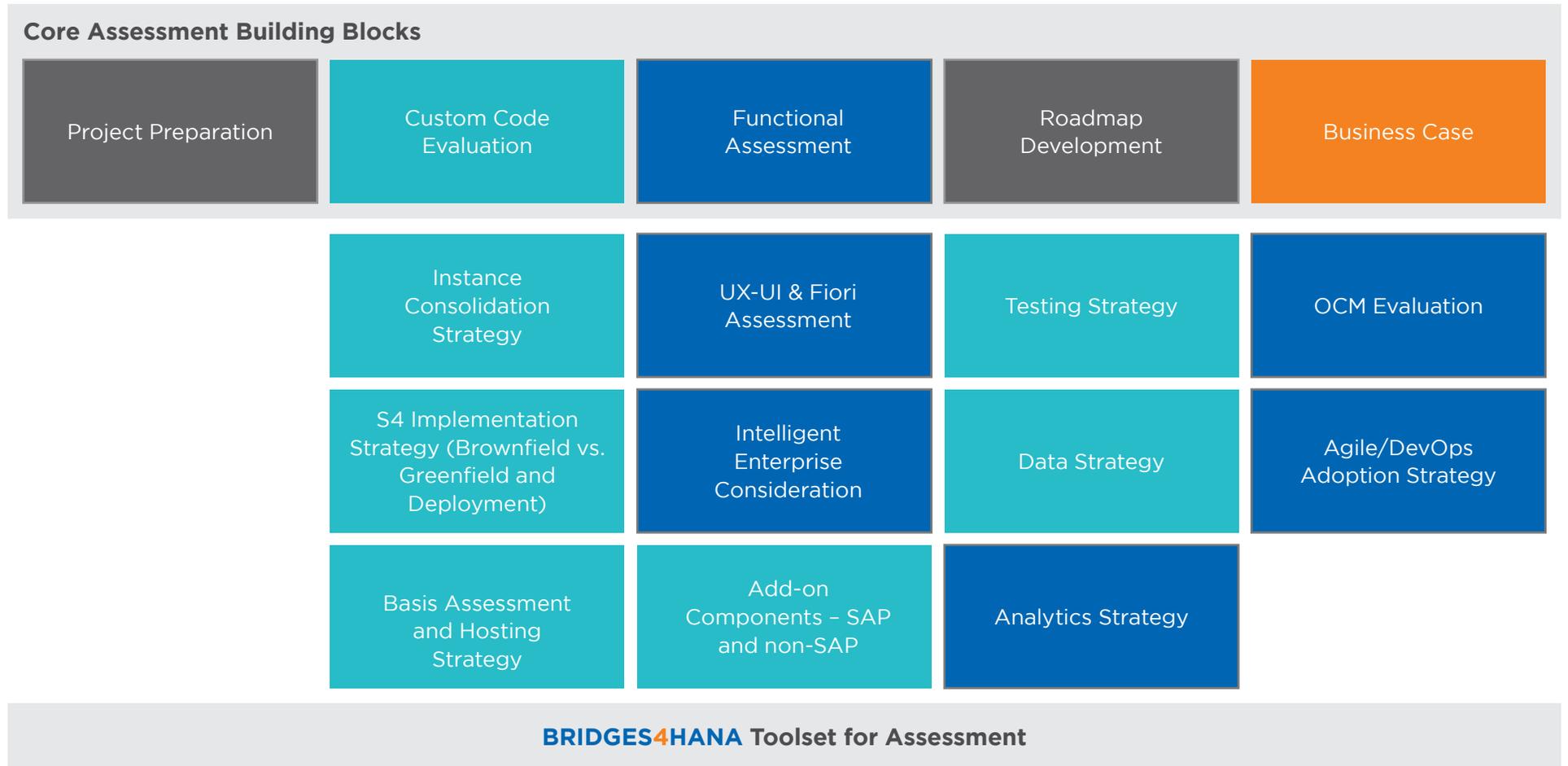
